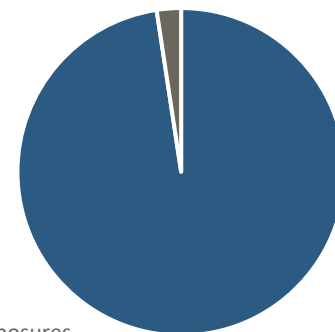

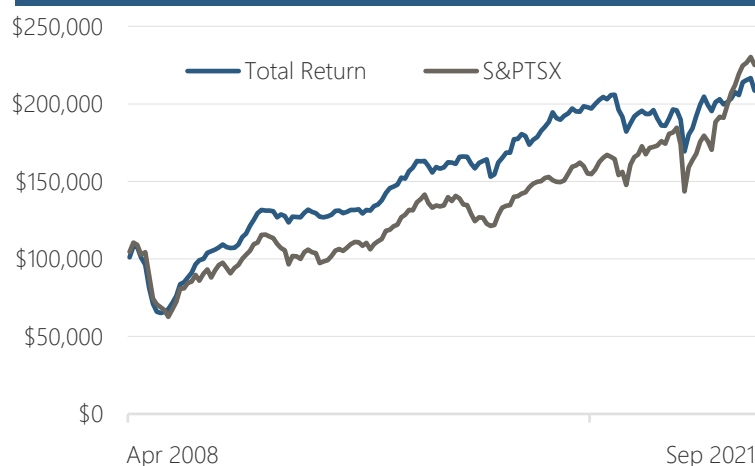
## "NET" ASSET ALLOCATION BREAKDOWN

## GROWTH OF \$100,000



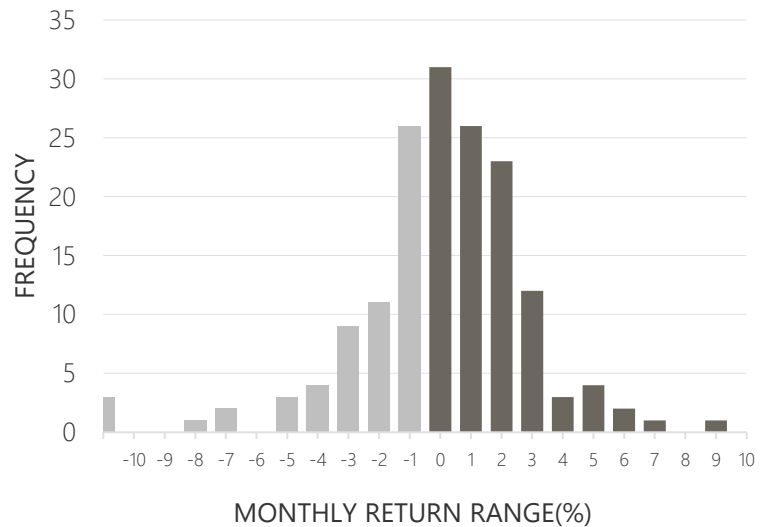
